

COMPLETE COLOUR Online Terms and Conditions

These Terms and Conditions are to be read in conjunction with Complete Colour Printing Trading Terms and Conditions that are detailed on Pages 3 & 4 of the "Application for Credit Account" published on the Complete Colour Printing Website and included at the Log In page of Complete Colour Online.

Online

Any electronic transaction committed by a client at Complete Colour Online, is deemed to be a firm order and commitment to the transaction which may include the purchase of goods and/or a specific logistics service in relation to any arrangement and/or agreement made between the client and Complete Colour Printing to trade Online.

Orders cannot be cancelled except upon terms that compensate Complete Colour Printing for all work done, materials used or specially acquired to complete the order, to the date of the cancellation. Orders, once confirmed at checkout, cannot be cancelled. If portions of the order have not been commenced, these portions will be ceased and charge for those portions of the order will not be made, except for a charge to compensate Complete Colour Printing for any costs incurred for work to date or the actions involved in cancellation.

Acceptance of any Online Proof created during any order for any eStationery (Online Stationery) items that is placed by a customer on any of Complete Colour Printing's online systems, is taken to mean a firm commitment to purchase said ordered goods.

Any changes to the set design/artwork parameters of any eStationery items that are provided by a Client to be placed as the working tool on Complete Colour Online will occur an additional charge as advised by Complete Colour Printing before that action commences.

Customer Data and Files

All Disks, tapes, compact disks or other media (other than the media supplied by the customer) used by Complete Colour Printing to store data for the purpose of completing the Order are and remain the property of Complete Colour Printing. The customer cannot require Complete Colour Printing to supply to the customer any data so stored. In the event that Complete Colour Printing does supply data so stored or created, Complete Colour Printing may charge the customer for supplying such data. Complete Colour Printing will not be held responsible for storing any data on web sites, server, disks, tapes, compact disks or other media when the Order has been completed. If Complete Colour Printing agrees to store such data Complete Colour Printing may charge to do so.

Client Data Backup
